#### **Known Issues**

#### General

An error message appears on creating a Transmission Order on non-Transmission resource [25009] -When trying to create a Transmission booking on a resource that does not have transmission settings configured, the system currently displays an error message ("The added or subtracted value results in an un-representable DateTime Parameter name: value") that does not indicate the correct problem.

#### **Issue Management**

IM Session and Issue Status Dropdown List Issue [25017] - In version 10.2 and higher, values in the Session Status and Issue Status dropdown fields display a number (the Status ID) after the Status Description when the same Status Description has been created in multiple Session Categories. In some cases, the list displays two or more entries with the same Description but different IDs; in other cases, the list displays one one entry with a unique Description and ID when one or more of the duplicates has been filtered out.

#### Library Movements

Shipping Form Accessed within Movement Has Wrong Values [24717] - When a user is viewing a Movement document, clicks the 'View Shipping Form' Action, and selects the "Shipping /Receiving Authorization" layout, the shipping form displays incorrect values. Using the same Action from the Library Movements list document and selecting the same layout displays the correct values.

#### **Schedule Book**

Order Type Change on Existing Quick Hold or Dynamic Booking in SB [25000] - In the Schedule Book, when the user clicks on an existing Quick Hold (WO and MO Type booking) or Dynamic Booking (any type) to open the booking popup window, the Booking Type field incorrectly appears to be editable, and changes made to the field are not saved.

#### Error when displaying [jm\_work\_order\_customer\_name]

Resolves an issue with old data showing an error when trying to open an Order layout with a Document Customization override setup to pull the order's Customer Name. Also corrects an error that did not show the Customer Name of a Parent Order via Document Customization. [20024 / zd6708]

#### Job

#### Work Orders Report throws an error when a certain number of orders selected is exceeded.

Resolves an error ("The incoming request has too many parameters") that would occur when running the Work Orders Report for a large number of orders. (This item was a Known Issue in v11.0) [22564 / zd8411]



#### **Media Assets**

#### Save Failed: Object Reference Error Saving Media Asset

Resolves an error message ('Object Reference Error Saving Media Asset') when saving a Media Asset and a column attribute is null. (This issue is fixed in v11.0 and later.) [22772 / zd8966]

#### Completing Operation on one service row also completes Operation on another service row

Resolves an issue where completing an operation on a Media Order Service row would also complete an operation on another service row. [20204 / zd5456]

#### Template Type Field no longer multi-select when searching

Resolves an issue where the Template Type criteria field on the Media Order Service Template List was no longer a multi-select dropdown. [20637 / zd7412]

#### **Cancel Reason Unavailable When Cancelling Service Row**

Resolves an issue where Cancel Reasons and related fields were disabled after cancelling a Service Row. [22340 / zd8641]

#### Service Template Issues Editing Default Specs

Resolves an issue when attempting to edit default specs in a Service Template. [23049]

#### Service row with multiple target sources is using the length from first target

Resolves an issue where a Service Row linked to multiple input sources is set up to bill by the lengths of the targets created was only creating transactions based on the length of the first target source. [23187 / zd9370]

#### Services display inactive status by default

Resolves an issue where inactive Services were displayed by default along with active Services based on Order Phase filtering. The system should now look for the first active Status of the correct Status Type.

This did not resolve the issue when the Phase option 'Service Status No' was set to an inactive Status which then applied that inactive Status to the Order. The resolution here is to set the Phase option to an active status. [24360 / zd9773]

#### **Project Management**

#### Additional Media Assets on a Project

Resolves an issue where the Project Media Asset list (pm\_project\_asset) allowed multiple entries with the same Asset ID. [23459 / zd9304]

#### Transmission

#### Long spinning wheel on Transmission Order resource selection

Resolves an issue where changing a Scheduling Resource assigned to a Service in a Transmission Order generated an error and displayed the spinning wheel/pacifier for a long time. [23272 / zd8823]

#### Moving Services does not update Display Seq

Resolves an issue where moving a Service Header while the header is collapsed did not correctly update the Display Sequence of the header and all its detail rows. [23305 / zd7184]

#### Work Orders

#### Order Duplicate doesn't duplicate Split Billing

Resolves an issue where split billing was not properly duplicated with an order. [22118]

#### **Duplicating Orders via SB Shifts Times (Time Zone)**

Resolves an issue where some orders created using the Order Duplicate feature had incorrect Begin and End times. [22557 / zd8329]

## System Hanging Busy with No error Message When Creating Order Transaction Template With Inactive Billing Code

A timed error message has been added for when a user tries to load a WO Template with an inactive Billing Code. [23146 / zd9461]

#### General

#### **Session Memory Leak**

Resolves a key source of the memory leaks impacting both our cloud and on-premises customers. This issue has resulted in high memory usage, and in extreme cases necessitates a service restart. Add bid detail to a Bid and then saving, expands all bid details headers that were collapsed. Resolves an issue where bid detail that was collapsed would expand when new detail was added or inserted. (This issue was reported in 11.0 and determined to affect 10.6 as well.) [22515 / zd8836]

#### Markup Percent Field in Budget Details is no longer a percent but a decimal.

Resolves an issue where the Markup Percent field required the user to enter a decimal number instead of a percentage. [22524 / zd8860]

#### **Creating New Change Control Template for Bid**

Resolves an issue where the "Bid" value was being cleared from the 'Limit To Document' dropdown field upon selecting it while creating a new Change Control Template. [22890 / zd9216]

**Cannot Update Billing Unit on WO Actual Billing Code Transaction if Work Order Created from Bid** Resolves an issue where Unit Type Codes in all upper case like "HR" caused an issue in code looking for mixed case like 'Hr'. A SQL script may be required to fix existing data. [23552 / zd10058]

#### Billing – Invoicing

#### Rate Attribute issue when same resource in criteria on two Rate Attribute definitions

Resolves an issue where a Rate Set with Rate Attribute Definitions was assigned automatically, and attempting to manually select a Rate Set afterwards was filtering out valid Rate Sets. (This issue was reported in 11.0 and determined to affect 10.6 as well.) [21683 / zd8065]

Resolves an issue where applying changes to a Scheduling View from the Items window would re-set Schedule Book rows to their original height on views where row height had previously been adjusted. (This issue was reported in 11.0 and determined to affect 10.6 as well.) [22592]

#### Active Resource is not Showing in the Scheduling Book Items List

Resolves an issue where an active Resource was not showing in the Items list under its Group for the Schedule Book. (This issue was reported in 11.0 and determined to affect 10.6 as well.) [23267 / zd9673]



#### Security

#### Error When Trying to Remove Roles from Change Control Template

Once a Change Control Template has been assigned to a record -- Bid, Job, Order, etc. -- the Roles within it cannot be removed. This updates the error text to give the user a clearer understanding of why the change cannot be made. [22764 / zd9150]

#### Transmission

#### Usability of Media Order

Resolves an issue where entering text into an input field in a grid control, and then quickly moving to another field sometimes clears the data entered into the previous field. (This item was a Known Issue in v10.6 and v11.0) [19013 / zd5564]

#### Organization Desc Field is Not Available in Document Class 2503

Resolves an issue in the Operations List document customization where the 'Organization Desc' field could not be added to Reference Doc Fields. (This issue was reported in 11.0 and determined to affect 10.6 as well.) [22115 / zd7101]

#### Moving Services does not update Display Seq

Resolves an issue where moving a Service Header while the header is collapsed did not correctly update the Display Sequence of the header and all its detail rows. [23305 / zd7184]

#### Work Orders

Order Transactions: Grid Updating Note Doesn't Allow Typing Text in Re-Class Note Resolves an issue where Grid Update was preventing the entry of text in note fields. [22893 / zd9218]

#### Search by % is not working for two words or more at a time in Manage Work Order Screen

Resolves an issue in Search windows (such as the Work Orders search), where specifying multiple search values for a single text field (such as W/O Description) would remove the % from the end of a search string after a search was executed. Note: When searching by a single value, the % at the end is assumed, but when specifying multiple criteria, it is necessary to add the % to the end of each value (including the last one) if the wildcard is desired. (This issue was reported in 11.0 and determined to affect 10.6 as well.) [23245 / zd9609]
